

REGULATION OF DISPLAY OF POLITICAL SIGNS POLICY RIVERSTONE HOMEOWNERS ASSOCIATION, INC.

WHEREAS, the property encumbered by this Standby Electric Generator Policy is that property restricted by the Second Amended and Restated Declaration of Covenants, Conditions and Restrictions for Riverstone HOA (Riverstone Homeowners Association, Inc.) recorded under Fort Bend County Clerk's File No. 2012104699 (the "Declaration"), as same has been and may be amended and supplemented from time to time ("Declaration"), and any other property which has been or may be subsequently annexed thereto and made subject to the authority of the Riverstone Homeowners Association ("RSHOA"); and

WHEREAS, any reference made herein to approval by the Residential Review Committee ("ARC"), means prior written approval by the ARC.

NOW THEREFORE, pursuant to the authority granted in Section Sec. 202.009 of the Texas Property Code, the Board of Directors (the "Board"), hereby adopts this REGULATION OF DISPLAY OF POLITICAL SIGNS Policy ("Policy"), which shall run with the land and be binding on all owners and units within the subdivision. This Policy replaces any previously recorded or implemented policy that addresses the subjects contained herein.

I. PARAMETERS FOR POLITICAL SIGN DISPLAY

Except as otherwise provided by this section, a property owners' association may not enforce or adopt a restrictive covenant that prohibits a property owner from displaying on the owner's property one or more signs advertising a political candidate or ballot item for an election:

- (1) on or after the 90th day before the date of the election to which the sign relates; or
- (2) before the 10th day after that election date.

II. RULES ON POLITICAL SIGNS

- (1) Signs shall be ground-mounted.
- (2) This policy limits a property owner to displaying only one sign for each candidate or ballot item.

prohibits a sign that: contains roofing material, siding, paving materials, flora, one or more balloons or lights, or any other similar building, landscaping, or nonstandard decorative component;



- (2) is attached in any way to plant material, a traffic control device, a light, a trailer, a vehicle, or any other existing structure or object;
- (3) includes the painting of architectural surfaces;
- (4) threatens the public health or safety;
- (5) is larger than four feet by six feet;
- (6) violates a law;
- (7) contains language, graphics, or any display that would be offensive to the ordinary person; or
- (8) is accompanied by music or other sounds or by streamers or is otherwise distracting to motorists.
- (d) A property owners' association may remove a sign displayed in violation of a restrictive covenant permitted by this section.
