Willingness to Serve Form

Nominations are now open for one (1) position on the Riverstone Homeowners Association, Inc. Board of Directors.

Requirement: Applicant must be an owner of record of a property within Riverstone Homeowners Association, Inc.

What are the responsibilities of the Board?

The Board of Directors responsibilities include, but are not limited to:

- Policy making
- Planning
- Oversight of Riverstone HOA management (which handles day-to-day operations)

Who serves on the Board?

The Riverstone HOA Board currently has three (3) positions. Two (2) of these positions are appointed by the Declarant and one (1) position is elected by Riverstone Homeowners.

The one (1) elected position is consistent with the provisions in Texas state law that requires 1/3 of the board to be elected by the Owners (other than builders or developer owners) when a community reaches 75% of its residential build out. Other than this provision, the Riverstone Homeowners Association Declaration allows for the Declarant to appoint any remaining positions and control the majority of the Board until it sells the last piece of land it owns.

How long is the Board member term?

The newly elected Board member will serve a 2-year term.

How is the winner determined?

Once the quorum is reached, the candidate who receives the most votes is elected. The quorum requirement is 10% of eligible Members.

Who tabulates the votes?

In addition to handling the voting process, a third-party company will tabulate the results to maintain the integrity of the voting. No one from the Riverstone HOA Board or Management will be involved in verifying and tabulating the votes.

When will the results be announced?

The results of the election will be announced at the Riverstone Annual meeting on Tuesday, November 28th, 7 p.m., at Anne Sullivan Elementary.
