- 4. Proof of identification (State ID, Driver's License, passport, etc) for all residents over the age of 18.
- 5. Anyone over the age of 18 whose name is not listed on the deed will need to provide additional proof of residence. Examples of acceptable Proof of Residency may include car insurance, utility bill, cell phone bill, etc. and must include the resident's name and current home address.

Annual Assessment Reminder

Your 2024 Annual Assessment Statements were mailed last month. As a reminder, your Assessments are due January 1, 2024. Please see the financial insert in this newsletter, or visit www.riverstone.com, for payment options. If you have not received your statement by December 15th, please contact the HOA office at CustomerCare@riverstone.com What's the easiest way to make your payment? Why, the Resident Portal of course! Visit www.riverstone.com to log in and make your payment electronically from your couch. E-Check payments are FREE! There is a small charge for debit card payments (\$5 flat fee) and credit card payments (3% surcharge). If you've never logged in before, you'll find your account number on your statement. (It starts with 1004) If you prefer, you may also drop your check off in the drop box in front of the HOA office.



Check Out Your Resident Portal

Did you know that you have access to your HOA account through our Resident Portal? The Resident Portal provides homeowners with convenient, real time, 24-hour access to your account where you will be able to view and update your homeowner information, view account information and make payments, view compliance violations, architectural requests, and more! You can access the portal from our website at www.riverstone. com by clicking the Resident Account Portal tab on the top of your screen. When you are logging into the web portal for the first time, you will need to select the "Create login" link. You will then enter your account number and email address. If you do not have your Account Number, please



contact us at customercare@riverstone.com. It will also be printed on your Assessment statement that was mailed out in November. If you are one of multiple owners associated with the provided account number, you are required to select your name from the list provided. 2024 HOA ASSESSMENTS

RESIDENTS OF RIVERSTONE,

Upon the review and consideration by the Board of Directors, the 2024 budget has been approved and the general assessment rate set at \$1,268. This is a 5% increase over 2023, and comes after a detailed planning and review process considering both Capital, Reserve, and Operating expenses.

For the 2024 Budget, 66% of funds are allocated to the continued landscape maintenance and improvements of the Riverstone community, including common areas, parks and pools, lakes and their associated utilities. 15% of funds are allocated to General and Administrative costs, 5% of funds for Recreation and Fun, including fitness center and tennis court maintenance, and 5% to Compliance for enforcement of deed restrictions. Additionally, RSHOA continues to properly fund the Reserve Account to ensure funds are available to repair or replace assets of Riverstone as it becomes necessary to do so. The remaining 9% of budgeted costs reflect a \$755,176 contribution to the Reserve Fund Account and \$39,000 to the Capital Projects Fund.

As a reminder, each gated neighborhood also has a separate budget and neighborhood assessment, as required by the neighborhood governing documents. That information is sent out to those neighborhoods individually with their Assessment Statement.

The Board of Directors believes this 2024 Budget reflect fiscally responsible solutions necessary to see Riverstone into the future. 1. Online Payments on your Resident Portal

Visit www.riverstone.com select "Resident Account Portal." Once you have logged into the Portal system, click on the black "Pay Now" button on the left of your screen. A pop-up screen will open with two options: Pay with eCheck or Pay with Credit Card.

E-Check

Clicking "Pay with eCheck through Alliance Association

Bank" will expand the One-Time eCheck payment window. Enter the required information, and your payment will be electronically withdrawn from your bank account and sent to our payment processing center. Please be aware that it can take up to 5 business days for eCheck payments to process and be credited to your account (although most are processed the next business day). You will receive an e-mail confirming that your payment has been processed. This service is FREE and easy to use.

Riverstone's Management Company ID is 7214. Your Association ID is R100. Your Account number is a 10-digit number located on the top of your payment coupon.

Credit Card Payments

Clicking **"Pay with Credit Card thru Alliance Association Bank"** will expand the credit card payment window. We can accept Visa, MasterCard, American Express or Discover. You will incur a 3% processing fee for credit cards and \$5 flat processing fee for debit cards. Please be aware that it can take up to 7 business days for Credit Card payments to process and credit to your account (although most are processed in 4-5 days).

Credit card payments can only be made online. Credit card payments are not taken at the Association office.

2. Personal Bill Pay

If you opt to use your Bank's bill payment feature through your Online Banking channel, please be aware that this will be sent via a check and may take up to 7 business days to reach our lockbox, even though your bank may withdraw the funds immediately. When setting up Riverstone HOA as a vendor merchant within your Bank's Payment system, please make sure you include the following information:

In ALL cases, payments are posted by DATE RECEIVED, not date submitted or postmark date. Please allow ample time for your payment to reach our lockbox. Your Account number and/or our billing address may have changed from last year. Please verify your information before mailing a payment.

Payments mailed to any other addresses will not be received by Riverstone and will be subject to late charges.

3. Personal Check via Mail

Personal check payments should be mailed to the **Riverstone HOA lockbox at P.O. Box 94104, Las Vegas, NV 89193-4104.** This address will be reflected on the assessment statement. It is very important to include your payment coupon along with your personal check so that your payment may be applied to your account.

By sending us your check, please be aware that you are authorizing Alliance Association Bank to use information on your check to make a one-time electronic debit from your account at the financial institution indicated on your check. If we cannot collect from your electronic payment, we will issue a draft against your account. If you do not have sufficient funds in your account, your financial institution may debit a fee from your account and Riverstone HOA will charge you a \$50 NSF fee and your payment will be considered late.

4. Payment Plans

In order to provide a choice of easy, convenient methods of paying your 2024 assessments, the following payment plans have been approved. Review each plan carefully and select the one best suited for you.

OPTION #1: You may pay your 2024 assessment in one or more payments before January 31, 2024. There is no handling fee associated with this option.

All Assessment balances after January 31, 2024 will accrue interest and late charges.

OPTION #2: If you need more time to pay, Payment Plan options of up to 6 months are available. Monthly administrative fees will apply.

OPTION #3: For those Assessments that become delinquent on the 1st day of February, the entire Assessment balance along with interest and administrative costs shall then be due and payable in three (3) payments.

The due dates for the Payment Plan will be February 28th, March 31st, and April 30th. If you need more time to pay, please contact us.

Fort Bend County Nonprofit Spotlight



The Fort Bend Boys Choir of Texas stands as a testament to the enduring power of music and the positive impact it can have on young lives. It provides a world-class choral education experience while fostering musical excellence and personal growth.

Founded by William R. Adams, The Fort Bend Boys Choir has been a shining beacon of choral excellence, education and inspiration for more than four decades. Adams has been a resident of Riverstone for more than 10 years.

"As a boy, I sang for several years in the Phoenix Boys Choir," Adams said. "In 1982 after moving into Fort Bend County, I held auditions to see if there was any interest in boys singing in an all-boys choir here. With over 40 boys auditioning, I was able to start this award-winning organization."

Today, there are approximately 60 boys ages 6 to 13 years old. Some perform in the Training-Town Choir, others in the Tour Choir. Both are treble choirs.

"The word treble means 'a high-pitched voice, especially in a young boy's singing voice,'" Adams said. "There are no tenor- or basschanged voices in this choir."

There are less than 30 all-treble boy choirs in the world which makes The Fort Bend Boys Choir unique. The boys have performed before three U.S. presidents. They have appeared with major opera





companies and symphony orchestras and performed in numerous cathedrals and concert halls throughout the world, including The Kennedy Center for the Performing Arts and the Sistine Chapel.

Membership is open to boys whose voices have not yet changed. No previous experience is necessary.

"Since a pleasant singing voice is a requirement," Adams said. "We are always looking for 'potential' for accomplishment, not 'level' of accomplishment. There are no set numbers for how many boys are in each choir, so we are always looking for new boys to audition."

Scholarships are available to those can't afford the tuition.

"We always have several boys each year who need scholarships," said Tiana Mortimer, Executive Director for The Fort Bend Boys Choir of Texas. "They would otherwise not be able to afford choir tuition and other activities like our summer and winter vocal camp and our summer performance tour. A donation specifically to our scholarship program would be a great help!"

Mortimer said that the choir's annual operating budget varies but is approximately \$250,000 per year. Only 15 percent is covered by tuition.







"I do apply for grants, but these are harder to come by because of our narrow focus on young boys only," she said. "The Fort Bend Boys Choir, as a nonprofit organization, relies on donations and fundraising primarily, along with some performance fees. Our fundraisers include a gala dinner and auction, a Bigfoot 5k and a Tamale and Salsa fundraiser. Approximately 80 percent of our expenses are music program-related with only about 20 percent administrative."

Adams said that Riverstone residents can also support the program by attending concerts and hiring the choir to perform at weddings or corporate events.

Both Mortimer and Adams encourage boys to audition as there is an expiration date on young voices.

"It could change at age 10 or 12 or even 14," Mortimer said. "You just don't know! Every time I talk with a family that is thinking about choir, I mention that boys can always play sports and do other activities, but they have only a short period of time to participate in boys' choir. I don't want a single boy to miss the opportunity to sing with us!"

Creamy Mashed Potatoes

Tennis Court Etiquette

- Talk quietly when standing near tennis courts that are in use so as not to disrupt players on adjacent courts.
- Never walk behind a court when a point is still in play. Wait until the point is over and then cross as fast as possible to get to your own court.
- When sending balls back to a neighboring court, roll them on to the back of the court.
- Never send them back while play is in progress. Also, if one of your balls rolls into an adjacent court, don't run after it, just wait for your neighboring court to return the ball when it's convenient.
- When reserving courts please be considerate to other residents by cancelling your reservation when you know that you will not be using it.

Tennis Court Reminders

- Court #6 at The Club at Riverstone and court #9 at Riverstone Blvd are designated as walk on courts. They are available for walk-on play during tennis court hours. Please be mindful when using the courts for walk-on play and limit your time to a maximum of 2 hours.
- Please remember all tennis court reservations are now available through the Riverstone app only.
- Remember that court reservations will be forfeited after 15 minutes of not showing up for scheduled start time.
- Tennis courts are for the use of tennis or pickleball play only. Any other sports or equipment are strictly prohibited. For more information refer to rule #4 at the Resource Center under Community Info.
